It can be used to detect total CB2 receptors in Western blots independent of phosphorylation. The CB2 antibody can also be used to isolate and enrich CB2 receptors from tissue lysates. It also detects CB2 in cultured cells and tissue sections by immunohistochemistry.</p>
